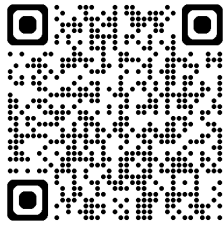

### Audition Information

- Mandatory audition practices will be held. Actual auditions will be Friday from 4:00 - until candidates are finished auditioning.
- Exiting Senior members will review dance fundamentals and teach the audition routines to candidates.
- All practices led by DHS seniors facilitating audition practices will be held during regularly scheduled clinic times only. Extra/optional audition assistance sessions, outside regularly scheduled times, will be available to all candidates, not exclusive to some. Any violation of this rule will result in a forced withdrawal of the offender's application for audition.
- For audition practices, Candidates should wear tennis shoes, or jazz shoes/ half shoes (bare feet are NOT allowed) and comfortable athletic clothing or dance wear that they can move and stretch in.
- Auditions and audition practices are closed to spectators and the public. Parents/guests are not allowed to wait with candidates during the audition process.
- Audition attire will be jazz shoes, half shoes or tennis shoes and **BLACK leggings** with a **PLAIN, SOLID black top**. Hair must be pulled back.
- Candidates will audition in groups. Audition order will be chosen at random.

- Candidates will be scored by a panel of judges on the execution of fundamentals displayed and the audition routine taught during the audition process.
- The Sponsor/Coach will determine the number of dancers to be chosen based on the break in the scores. After tallying the scores, the top scoring candidates will make the team.
- Members of the new team will be contacted about next steps. Please be sure accurate contact information is listed.

### **Who Can Audition?**

Below is an excerpt from the Daphne Jubilee Girl Constitution outlining the qualifications for membership. Please refer to this document to understand the eligibility requirements for auditioning for the team. Additionally, review the section on the responsibilities of a Jubilee Girl to fully understand what is expected of candidates if selected to join the organization.

## **Jubilee Girl Constitution**

### **ARTICLE I QUALIFICATION OF MEMBERS**

SECTION 1: Members of the Daphne Jubilee Girls must be enrolled in Daphne School system or Baldwin County Virtual School for the full duration of the 2025- 2026 school year.

a. Qualifying members must receive three (3) affirmative teacher evaluations. Candidates unable to receive three (3) satisfactory teacher evaluations will not be eligible to audition.  
(Forms will be emailed to teachers to complete.)

b. Disciplinary and school attendance records will also be considered in the selection process. Candidates with severe disciplinary infractions and/or outstanding truancy will not be eligible.

SECTION 2: Each member must participate in the Spring session of tryouts by performing basic dance techniques and a choreographed audition routine taught by the existing Senior members of the DHS Dance Team from the previous season.

SECTION 3: Jubilee Girls are expected to maintain a C average (2.5 GPA) with no failures and keep class attendance in good standing.

SECTION 4: Parents and members will sign and return a form stating that they have read the policies outlined and understand the rules/regulations for participation. These signatures also indicate an acknowledgement of the physical requirements for participation. Parents will assume responsibility for any injuries that may occur as a result of practice or performance.

### **ARTICLE II RESPONSIBILITIES OF A JUBILEE GIRL**

SECTION 1: The DHS Dance Team will perform at the following activities and events throughout the 2023-2024 year:

- Select Football Games and Basketball games
- Parades - Including select community parades
- Pep Rallies
- Summer UDA Camp - (Scheduled for **June 22nd - 25th**)
- Special performances - Invites / Community performances
- Scheduled Dance Competitions (this may include State, Regional, and National Competitions)

Summer practices will be held Tuesday, Wednesday, Thursday 7:00 - 10:00 A.M to prepare for camp.

## FINANCIAL REQUIREMENTS

Candidates auditioning for the Jubilee Girls should understand that being a member of the team comes with financial obligations. While all efforts are made to select cost effective uniforms, equipment, and accessories, it costs a **minimum of \$1200** (which is paid in installments throughout the Summer and Fall months) for a team member to purchase uniforms, practice wear, accessories, and other necessities. There are **also** expenses for dance camps, travel and competition fees that vary from **\$400-\$1000 per dancer per event**. Fundraisers will be made available to help cover or offset these costs.
